Abstract. The purpose of this work is to compare the capabilities of scientific social networks and CRIS in relation to the goals of the scientific community. Scientific social networks have been developing for almost twenty years as a platform for the exchange of opinions and ideas, the implementation of scientific communication and the integration of researchers into the scientific community. However, empirical studies show that the scientific community is not very interested in this function of scientific social networks: researchers are mostly interested in open access initiatives, as well as representation and self-presentation, including demonstration of personal achievements to a wide audience. Given the researches' lack of focus on communication, Current research information system (CRIS) more accurately meets the needs of researchers in demonstrating scientific achievements and, more importantly, in finding information. Nevertheless, scientific social networks still have more developed recommender algorithms. However, the use of such algorithms leads to the danger of the formation of "echo-rooms" that nullify the need for pluralism of opinions and critical analysis of information.

## Virtual Reality and Media as Subjects of the Socio Etymological Approach Analysis

**Abstract.** The article attracts the reader's attention to the possibilities of the social etymology method, used mainly in foreign humanities. Thus, the authors believe that in the case of supplementing the method with a culturological component, its effectiveness in conducting culturological research significantly increases. The field of knowledge described by the terms "virtual reality" and "medium" is chosen as the object of application of the method. The authors point out that in modern studies of the phenomena reflected by the above terms their cultural component is overlooked due to the dominance of the technocratic approach. At the same time this component was not only decisive in the emergence of terms, but continues to inform them a cultural character throughout history and in modern reality. Thus, the essence of virtual reality is proposed to be characterized not through the technical means of its provision, such as a processor, video card, etc., but by understanding it as a second reality – the reality of culture. Among the cultural qualities of virtual reality, the article draws attention to such a component as morality. When the article deals with the content reflected by the term "medium", the authors point out that the cultural and historical circumstances of the use of the term gave it the status of subjectivity. However, at the same time, they deprived medium of the quality of an independent translator of a cultural message. That was the damage done to the moral component of the medium.

# The Role of Multiscreen Culture in the Formation of a New Socio-cultural Type of a Person

**Abstract.** The article is devoted to the problem of transformation of screen types in modern culture, as well as the influence of the multi-screen cultural complex on the formation of new personality characteristics of postmodernity. The article analyzes the role and significance of such basic types of screen as cinema, television, computer (including portable), tablet and smartphone. The methodology for solving this problem consists in the application of empirical and theoretical methods, including historical and comparative, as well as analysis of the available scientific and technical base. The author

notes the multiscreen as a distinctive feature of postmodern culture and arrives at the conclusion that the socio-cultural type of "screen man" was formed under the influence of the expansion of multiscreen technologies. The author concludes and generalizes the characteristics of modern screen culture and "screen man": a) the screen has become a cultural phenomenon that translates in a special way and eventually transforms and creates its own values and meanings; if the cinematic and television types of the screen reflected reality, then the emergence of multimedia technologies made the screen an independent cultural subject, reproducing its own constructions of reality, but "implanted" in the physicality and behavior of a person. The "screen person" seems to have a new organ; b) the main properties of the screen as an active cultural subject in a multi-screen culture are spatial dynamism, polytextuality, spatial projectivity. The article argues that the "screen person" is a new socio-cultural type that demonstrates such characteristic features as increasing the value of publicity, fame, success; hypertrophy of the visual perception channel; clip thinking; the ability to mimic based on cultural cliches and artistic stereotypes; the acquisition of personal and social identity through screen images; the absence of boundaries between reality and screen reality; the dominance of mass consciousness over individual consciousness.

Some episodes of her professional pedagogical life have been recreated in this article. The author describes the beginning of T. B. Khazanova (Narskaya)'s professional way at the institute during the first years of his foundation in the part "Beginning". History based on the documents of the United State Archive of the Chelyabinsk Region, concentrated in the fund dedicated to the the Chelyabinsk State Institute of Culture and Arts. The study of documents from the personal fund of Tamara Borisovna and Vladimir Pavlovich Narsky (which is beginning to take shape in that Archive) plans during next future. The author identified documents and arguments of inviting Tamara Borisovna to work as a teacher at the new Institute of Culture and Arts in the South Urals, her connection with practical choreography and service to art in the theater is emphasized, which left an imprint on her entire subsequent professional path. The first actions of T. B. Narskaya as the head of the department of choreography is describes, and the beginning of her involvement in the research work. Her active participation in scientific and practical con-ferences with approbation of theoretical research and their translation into the practice of choreographic art are highlighted.
