Photogeny of The Russian North in Exhibition Space of Pomorye Regional Visual Culture in Early 20th Century

Oneirological Problems in the Views of Ancient Greece Thinkers

The article reveals peculiar views of ancient Greece thinkers on the essence and nature of dreams. The authors pay much attention to oneirological problems in the works of ancient Greek thinkers (views on the dreams by Plato, Aristoteles, Hippocrates, Democritus, Artemidorus Daldianus, Heraclites, Cicerones), the analysis of which has allowed the authors to point out the items of dreams origins and features distinguishing dreams and reality along with dreams classifications and explanations. Thus, in the works of Plato the authors of the article discovered the efforts of the dreams essence determination and stressed the complexity in determining the difference between a dream and reality, they also showed inter-connection between spiritual and fatal parts of a human soul. The works by Aristoteles show rationalistic approach to dreams when he denies their godhead and stresses their natural origin as a result sense organs activity. Hippocrates and Herophilus offered the tendency of dreams rationalistic understanding and classification from the viewpoint of human physiological state correlation. The authors find the explanation of the dreams' nature in the views of Democritis who defines dreams as the radiation essence with the physical cover and as a form of idea of reality free form senses. The works of Artemidorus Daldianus reveal the effort to systematize the images connected with the dreams' interpretation including the analysis of their symbols the result of which allowed to compose a dream book in which the authors used individual approach to interpret dreams. We also meet rationalization in the views on dreams' essence in the works by Heraclites who states that a dream reflected our own inner world. Cicerones gives the classification of prophetic dreams of stoics according to their understanding of the connection of dreams with the souls flotant in the atmosphere. In conclusion the article says that philosophy of Greek antiquity tried to find its own approaches to oneirological problems and made a considerable contribution to the formation of one of the first dreams theories which in its key items has become the grounds of the Western Europe oneirology.
